# **Project Partnering Agreement**

The Directors of Site Group International Limited ("Site", ASX:SIT) are pleased to announce the signing of an agreement for Site Group with Sayed Kadhem Al Durazi & Sons ("SKD") for partnering, management and operation of the UniTraining Centre: Bahrain's Skills Demand and Assessment Centre in Bahrain.

The agreement includes a 10 + 10 year Manage and Operate Agreement with 2 Phases. Phase 1 commences in December 2019 and includes training across equipment operations, lifting, welding and mechanical trades with at least 200 trainees guaranteed in this Phase. Phase 1 also includes a Feasibility Study (FS), with the aim to support the Financial Investment Decision (FID) to locate the Gulf Cooperation Council's (GCC) first Safe Live Process Plant (SLPP) within the UniTraining Centre. The timeframe to complete the FS and FID for the locating of an SLPP is 31 March 2020. Phase 2 operations will expand as determined in the FID.

UniTraining Centre fills a market need in Bahrain for quality, competence-based vocational training and assessment, enabling Bahraini's to enter a growing segment of the workforce in high demand areas.

It is also intended to fully integrate Site's Engineering Work Experience Programme (EWEP) which provides Bahraini engineering students, the opportunity to gain a competence-based work experience that supports their graduation as certified engineers in Bahrain and the region.

SKD CEO Sayed Hashem Al Durazi said, "The development of this facility in high barrier to entry products, skilling workforces focussed on sustainable employment and long-term workforce development using Site's well proven capability in workforce development is great for Bahrain. It is an essential part of the Bahraini vision and will provide significant capability for workforce nationalisation in the gulf states. Our partner Site has a proven track record in achieving these objectives. And SKD is proud to be partnering in this much needed venture and this workforce empowering initiative for the region."

Site's CEO and Managing Director Vernon Wills added, "SKD is a leading company empowering Bahraini's to work in the growing sectors transforming the Bahraini economy. The UniTraining Centre will be a regional leader in these training programs. Our success in national workforce development in Saudi Arabia, Myanmar, Philippines, Papua New Guinea, East Timor, Malaysia, Indonesia and Australia and programs in Bahrain has made Site the natural choice to work with SKD to maximise the value of their investment in the first Skills Demand and Assessment Centre in Bahrain," Mr Wills said.
